4. Committee Reports

4.1. Membership

 - This email will include a call to join committees
 - We are looking for a social media handler
 - Need to make a list of people to send the "we're back, hi!" email to
 - Autumn just sent an email connecting Membership Committee to Jackie who can provide that list
 - Brainstorming about membership drive
 - Inquiry into the website process a local website exists but no way of accessing it
 - Nicole is connected to Mary Lohr (?) who can help on how the National does the website (?)
 - O Does the National have an onboarding document?
 - Yes, currently getting feedback from the three who are undergoing orientation, but the checklist can be sent over by Autumn

4.2 Financial

- We just opened the account, Mimi, Autumn and Chengyan went to Scotiabank and signed the documents and got the debit cards
- E-transfer may be complicated until we figure out how to connect the right emails to the account

- Let's get the funds from the National by asking Jackie for a cheque Jody will communicate
 with Jackie, send Chengyan's address as a place to mail it to, and Chengyan will deposit the
 cheque at Scotiabank
- Autumn has been keeping a running tally of expenses so far
- Autumn will make a report for Jody to present at Saskatoon

4.3 Events

- BYO Karaoke is a go at Vancouver Performing Stars
- Mimi presented a budget for the event:

- o Costs based on estimates of 60 or 100 guests
- Costs \$800-1200, revenues \$1400-2600, both scenarios should be net positive
- We feel 60 is very achievable
- Autumn will check about GST passthrough rates
 - Jody will reach out to Ontario section to see what they do
- We will determine what up front costs are necessary depending on RSVPs
- O Do we have enough cashflow to do this?
- o If this is a concern, we can nix the alcohol
- We will determine depending on whether the National will advance us two fiscal year's worth of funding
- o The location is solid, so we have some time to work out the details
- Chengyan presented on the ticketing platform Zeffy
 - o Asked Ziyian Kwan from Odd Meridian Arts/Morrow about experience with it
 - Generally happy with it, they pay via direct deposit to a bank account weekly/monthly (based on choice)
 - o Ziyian offered to let us use their Zeffy account and Square unit to trial it
 - Board generally agreed to proceed with Zeffy, Chengyan will follow up with Ziyian and come back to the Board
- Populating the volunteer positions for the event:
 - o Check in with Ace?
- Talk to Tim about potential gear donation from Riggit
- Nicole can also fill in gear if needed
- Mimi and Nicole can bring some screens/TV for karaoke lyrics
- Can we do a site visit? Sometime between September 3-6? Mimi will arrange
- Future tax workshop event with Mel in November Nicole has connected, waiting for email follow up
- Jamie will also talk to Terrence about it.

4.4 Governance
