Programming honorariums. \$1.50 for e-transfer fees. Current balance \$629.59. Michael notes that we had more plans to spend honorarium money that was unspent. Russell notes that National is shifting to a consistent deposit of annual funding instead of a request by each section. Notes a shift to funding process for extra programming.

7. Report of the Winnipeg Rep – Michael Duggan

Winnipeg had slower activity this year. Appreciates having another Manitoba representative on the board. Michael was able to meet up with Rick Boychuk informally in person in Saskatoon in December 2023, representing the first in person meeting between provinces for the section. Notes programming committee actions of a Green Theatre infosession with Daina Leitold, and a Working for the Winnipeg Fringe Info session with Allison Loat from the University of Winnipeg and Tori Popp from the Winnipeg Fringe. Notes the meet and greet was well attended in Winnipeg. Uptake on Winnipeg membership is slow.
